Summary

Title: The aVersion Project, 1982 to 2001

Size: 4 standard size archive boxes, 1 lever arch file.

Restrictions: The original interviews are embargoed to protect confidentiality.

Brief historical background: This research report focused on human rights abuses of gays and lesbians in the South African Defense Force by health workers during the apartheid era. It was a collaborative project between GALA and the Health and Human Rights Project, associated with the Community Health Department at the University of Cape Town. This project was supported by the Joseph Rowntree Charitable Trust. The research team for the study was comprised of Mikki van Zyl, Jeanelle de Gruchy, Sheila Lapinsky, Simon Lewin and Graeme Reid. Since completion, the findings of this project have been widely disseminated through the media in South Africa, the United Kingdom and Canada.

Description: Research report on human rights abuses of gays and lesbians in the South African Defense Force by health workers during the apartheid era. Includes final report and executive summary, interviews (some embargoed), and background information. The collection also includes the subsequent coverage of the report (and related stories) in the South African media.

Scope and content.

Below is an excerpt from the introduction to the executive summary of the aVersion Project Research Report:

"Our interest in the subject of human rights abuses in the military was sparked by reports cited

in the submissions to the South African Truth and Reconciliation Commission. Exposing past violations of human rights and understanding the context in which they occurred is important in facilitating national reconciliation and building a culture of human rights in South Africa. During the period 1960 to 1991 many South Africans were conscripted into the SADF or became permanent force members. Some of these soldiers received medical treatment without their consent or were abused by army health professionals and medics because they were perceived to be homosexual or to have same -sex partners.

This study investigated and documented these alleged abuses in the military. We interviewed survivors of medical abuse and their family or friends, as well as other individuals who could cast light on particular aspects of the research. The interviews give us a glimpse into the experiences of those allegedly abused by health professionals in the military."
