

What is It's Time, Massachusetts!?

It's Time, Massachusetts! (ITMA), a chapter of It's Time, America! (ITA), is a public advocacy organization. We seek to obtain legal protections for people with gender-variant expression in the Commonwealth of Massachusetts. Gender-variant expression is any personal presentation that does not conform to socially prescribed gender roles or modes of presentation. Gender-variant people are at increased risk of violent attacks. including homicide, often are discriminated against in housing or employment, and often are targets of harassment and ridicule. Gendervariant people can be found in all walks of life. Our goal is to make this Commonwealth a safe place where these individuals can enjoy the liberties that most citizens take for granted, including (but not limited to)

- access to gainful, safe, and legal employment
- access to public spaces without fear of harassment or violence

• access to public rest rooms and fitting rooms without legal complications

On whose behalf is ITMA advocating?

ITMA will advocate on behalf of the differently-gendered, including

- individuals who experience their gender as incongruent with their birth sex (i.e., transgendered, including crossdressers and transsexuals)
- drag queens, drag kings and other gays, lesbians and bisexuals who do not appear straight
- individuals born female, with masculine features, such as unshaven facial hair
- individuals born male, with feminine features, such as breasts (gynecomastia).
- intersex individuals (people born with ambiguous primary and secondary sex characteristics, sometimes referred to by the pejorative term,

"hermaphrodite"), particularly when their intersex status results in their not looking feminine or masculine "enough."

Who can help?

ITMA welcomes help from:

- Gender-variant people
- Friends and relatives of gendervariant people
- All advocates for equality and inclusion, without exception.

Preservation of the status quo for gender-variant people is not an option.
