Cross-Port Basics

Fourteen girls attended the February meeting. Coming from Bay Village & Dayton OH, Indianapolis & Seymour IN, Lexington & Louisville KY, and our regulars form the Greater Cincy area. New were Dolores, Julia, and Cheryl with a special guest appearance by Jennifer. We've heard about her but didn't think we'd ever meet her. Thanks to everyone that took the time to come.

We started early by watching the tape of <u>Night Talk</u> which Linda, Sharon, myself and my spouse appeared on. The show we felt went very well and we enjoyed it a lot. The first three mentioned could have gabbed on all night. We thank Dick Wolfsie for inviting us to talk about something that means so much to us. We have received about 10 letters from girls that saw the show and want information about Cross-Port.

We will be changing the starting time of the meetings beginning in April to 7: 30. Since most people that dress are coming that way and almost no one is dressing here, the added time will help me to get ready. For March you need to get here by 7: 30. The Fun Fashions show will start at 7: 30 and good girls don't come late to Fashion Shows. If we have a poor turn out, it will be a COLD DAY in you know where, before we schedule anyone else to come and talk to the group. If you get my drift.

As of January we officially began our screenings before people can attend a meeting. This is not meant to keep people out as much as to insure the security of all of you and of my home. It also helps new people feel more comfortable coming to their first meeting if they have already met some of the people. We have girls in different areas that will help out so people don't have to drive to Cincy for the screenings.

The meeting broke up around 11: 00 pm and people headed for "The Subway".



There is no law that permits us the right to cross-dress. Being an ex-police chief, with law books in hand, I will point out the pros & cons of our concern. Since my training, expertise and law books are for Ohio, the information is good only in Ohio. There is no constitutional right enabling us to cross-dress in public. There are some vague laws and statues still on the books of some of the cities and municipalities through out the state, many of which are usually over looked but which could be enforced if the need arose. Since cross-dressing, in itself, is not illegal in the state of Ohio the problems arise from the actions of the cross-dresser.

Some of the No-Nos are:

1) One sex using the restrooms and dressing facilities of the other sex. Don't use the women's restrooms in public places. There are laws against it.

2) Disorderly Conduct - Chapter 2917. 11 of The Ohio Revised code.

A) No person shall recklessly cause inconvenience, or alarm to another, by doing any of the following:

1. Engage in fighting, violent or turbulent behavior

Make unreasonable noise, offensive utterance, gesture, or abusive language.

3) Insult, taunting, or challenging, or conduct which is likely to produce a violent response.

4) Hindering the movement of persons.

5) Creating a condition which is physically offensive to persons.

B) No person while voluntarily intoxicated shall do either of the following:

1) In a public place or in the presence of two or more persons, engage in conduct likely to be offensive


 Or to cause inconvenience, annoyance or alarm to persons of ordinary sensibilities.

Disorderly Conduct is a misdemeanor of the 4th degree with penalties of up to 30 Days in jail and up to \$250 fine or both.

As you can see under sections A5 and B1 – Sober or Drunk you could be arrested and jailed if someone in your persence is offended by your dressing.

If you should be stopped while driving, you can not be arrested for cross-dressing as long as you comply with all the officers request, since the law states that he/she must overlook that which offends the "normal" person. Give the officer your correct drivers license and state that it is your license. Do not state that you are anything other then a male and don't give him/her a another reason to arrest you and you should be alright. Even if he/she is not polite to you, BE POLITE to him/her. If asked why you are dressed state where you are heading. Be truthful. You should know that once you have provided your license, registration and reason for being dressed that is the only information you are required to give. If asked where you are employed you do not have to answer. State that you choose not to give that information. I'll talk more about the law and cross-dressing the next time.

I know for some, this kind of group is not what they are looking for, and for others the meeting are not easy to get to, but for many they are just plain afraid. We all know because most of us have been through it. There is a great need to meet and talk with others and a great fear of doing so.

Maybe, if some of you, would write to me about how you over came your fears I could put them into some kind of letter to send new people.

I did manage to go to "All Saints Chapel" the other week. The service was great even though there was a small group. I had met several of the members when they performed as the "Chapelettes" at the <u>Golden Lion</u>. They raised \$260 for ASC and the girls donated their \$220 in tips to Aids Volunteers of Cincinnati. They are truly a warm bunch of people.

Finally, if the "InnerView" seems shorter this month is really isn't. I used a slightly smaller type which allows me to put more information in a little less space.

Well, that's about it for this month. Until the next time "Put on your red dress baby, cause were going out tonight".


