## POST OFFICE TAKES ACTION AGAINST PHILIP SALEM AFFILIATE

(Van Nuys, CA) -- Postmaster William Jackson, acting on a complaint by "Cross-Talk", has issued a formal Prohibitory Order against Real Swingers Connections of Las Vegas, publishers of "TV Guy" magazine.

As previously reported in "Cross-Talk" (November 1990 and January 1991), the magazine in question is the latest home for "Dr. Philip Salem", who is notorious for deceiving unsuspecting members of the gender community. Salem has on numerous occasions — including a column in "TV Guy"—claimed to be a psychologist trained in gender issues, although he is not a doctor. His ads in "TV Guy" feature his "North American Transposetiat (Transposerus) Contact Sarvice" "North American Transvestite/Transsexual Contact Service" address. He has also published photographs of several people without their permission, including "Crossdressers Quarterly" publisher Danielle Moran.

In the Prohibitory Order dated April 19, 1991, Real Swingers Connections was advised that their mailing was considered to be "a pandering advertisement offering for sale erotically arousing or sexually provocative matter" and ordered them to cease all mailings to "Cross-Talk"s post office box. Continued mailings in the face of this order violate Title 39, U.S. Code, Section 3008.

Real Swingers Connections was also ordered to remove "Cross-Talk" from its mailing lists and to cease the sale, rental, exchange, or other transaction involving any lists bearing it.

## RENAISSANCE BOARD REVOKES READING CHAPTER CHARTER

(Philadelphia, PA) -- At its January meeting, the national board of the Renaissance Education Association voted unanimously to revoke the charter of its chapter in Reading, PA. The board also voted to take steps to ensure that members who had paid dues to the Reading chapter receive the full value of their membership.

The group in Reading had not met for several months, and the board had made numerous unsuccessful attempts to contact Susan Marshall, the leader of the chapter, to determine the status of the group. The vote to disband the chapter came after those numerous attempts went unanswered.

"Although we are disappointed that the Reading chapter had to be disbanded, we acted so that the former members wouldn't continue in a state of limbo," said Paula Jordan Sinclair, national managing director of Renaissance. "The motion to disestablish the chapter also contained our pledge to continue to provide the service those members paid for. They will continue to receive the 'Renaissance News' and the

## "UAR BETUEEN THE ALPHAS" WITH CHANGE OF LEADERSHIP

(Los Angeles) -- Recent developments have all but ended the dispute between the two Tri-Ess chapters serving the Southern California region.

Tri-Ess national board member Kymberleigh Richards has agreed to assume the presidency of Alpha chapter, allowing Tri-Ess founder Virginia Prince to move into a non-leadership role in that chapter. Prince had been the only remaining officer in Alpha after the bulk of its

membership opted to form the new chapter in August.

In light of Richards' actions, the new chapter voted at its March 2 meeting to change its name from Lambda Alpha to Sigma Chi. The question of confusing names had created the impression that there were two "Alpha" chapters, and had been a major point of disagreement between the two factions.

In announcing the leadership change in Alpha, Richards indicated a need for the dispute to be settled by a consensus of the Tri-Ess members in the region, and hoped that her "taking the reins" would alleviate the personal differences between the Sigma Chi membership and Prince that had caused the split.

Responding to her call for unity, the Sigma Chi membership voted to change their meeting night, effective in May, so as not to conflict with Alpha meetings.

Prince, citing the fact that Alpha was the first TV group in the country, as well as the flagship chapter of Tri-Ess, applauded the diplomatic efforts on the part of all those involved. She further expressed her hope that the combined membership of both chapters would now be able to create a stronger presence for Tri-Ess in the region. Richards added that Sigma Chi's recent actions would allow for each member to individually decide which chapter or chapters to support. Acting Sigma Chi president Janyne Cresap said she was happy to "have this all behind us". [Christine Hochberg]

## TRANSSEXUAL UINS LAUSUIT AGBINST BOFING

(Seattle, WA) -- A male-to-female transsexual has won a ruling in Superior Court here that gender dysphoria in a disability requiring accommodation by employers. The TS, identified only as "Jane Doe", was fired by Boeing from her job as a computer software engineer when she wore a string

to pink beads to work.

Doe began the sex-change process with hormone treatments in the spring of 1984. She testified that her supervisor at Boeing had shown "understanding" when she informed him of her condition in 1985, and that her co-workers had also accepted and supported her. The company gave her a new identification badge bearing the new name she had legally adopted, and the U.S. Department of Defense renewed her security clearance. By this time, Doe had worked at Boeing for seven years, receiving numerous certificates for "her for seven years, receiving numerous certificates for "her personal initiative, ingenuity, dependability, professional ability and dedication"

When Doe began the pre-operative phase of her sexual transition, her physician instructed her to live as a female for one year. Although she was not specifically told to wear female clothing, she felt "it would have been impossible for me to meet minimum medical standards if I did not dress as a

female while I was at work"

Doe notified her supervisor and co-workers in advance of changing her attire and explained the reasons. The supervisor testified that in response to the news Boeing imposed certain restrictions on her, mainly "no skirts or dresses" and no using the women's restrooms. He said that no disruption or complaints from co-workers resulted, although others testified that some employees were uncomfortable with

Doe's transformation

Doe complied with the restroom ban at first, driving a half-mile to a public restroom when necessary. But as her employer's and co-workers' acceptance of her situation appeared to solidify, she would use the women's room "in emergencies". Her supervisor testified that he did not notice which restroom she was using, but a male employee complained when he saw Doe leaving the women's room last September. Boeing, which has no official dress code for its engineers, then told Doe she could no longer wear feminine attire but told her supervisor to base his judgment of the appropriateness of her dress on her total appearance, not on any particular item of apparel. Boeing reiterated the women's restroom ban and told Doe that the various restrictions imposed on her would be lifted only after the sex-change surgery.

Fifteen Boeing workers sent a letter to management declaring that Doe's dismissal would be "an unfortunate and inappropriate action". They stated further that her changes in lifestyle and appearance were "her personal attempts to cope with an uncommon, but genuine, inner conflict, something the rest of us have not had to face", and that "whether we individually approve of these changes is irrelevant in the workplace. Her professional conduct and competence have not changed ... (we) believe that those who disagree misunderstand the situation and would change their opinions if they knew (her) as we do." Nonetheless, management fired Doe.

The American Civil Liberties Union sued for Doe's reinstatement, claiming that her condition constituted a disability under Washington's anti-discrimination law, and that Boeing had violated the requirement that employers reasonably accommodate the sensory, mental or physical limitations of employees unless they can show that such accommodation would adversely affect the conduct of business.

In his ruling, Judge Frederick Rasmussen stated that the case — the first of its kind in the state of Washington was "about a unique human condition and a case about human dignity and the need to be respectful of that". However, while holding that Doe's condition is a disability under Washington law, the judge also ruled that Boeing has reasonably accommodated Doe. ["ACLU News"]

(Beverly Hills, CA) -- Actor Scott Bakula, who has played both men and women on the "Quantum Leap" television series, was named international man/woman of the year in broadcasting by the Hollywood Radio and Television Society.

Bakula pičked up the honor at the group's annual International Broadcasting Awards dinner March 21 at the Beverly Hilton. Among the female characters he has played in the creative NBC series are: a secretary, a mother, a beauty contestant and an unwed pregnant teenager. ["Times"]

## GENDER ALTERNATIVES LEAGUE OFFERS SUPPORT TO CONGRESSMEN

(Napa, CA) -- The Gender Alternatives League (GAL) has urged President Bush to honor a request by 40 members of Congress who have asked him to sign an executive order rescinding the military's policy of banning gays from serving in the armed

forces.

While applauding the actions of Rep. Gerry Studds (D-MA), an openly gay Congressman, GAL's National Executive Director Cynthia Howard said in her letter to the President that such a reversal would be discriminatory and objectionable to other minorities who serve in the military although their lifestyles are also banned. Howard pointed out that at least 3% of all military personnel are transgendered, and that at least 90% of those are heterosexual. In calling for a similar action by the President, Howard

has asked gender community organizations to begin a letter-writing campaign in support of lifting the ban in the

military against transsexuals and crossdressers.

Among those signing the request for Bush to eliminate the 1943 Pentagon policy were Los Angeles Democrat Henry Waxman and Pat Schroeder (D-CO), a ranking member of the Armed Services Committee. [Kymberleigh Richards]

## TRANSSEXUAL INMATE SETTLES LAUSUIT WITH NEW YORK STATE

(Albany, NY) -- New York State has agreed to pay a transgendered inmate \$25,000 to settle a lawsuit that charged she was harassed and sexual assaulted by guards in the men's prison where she was incarcerated. In addition,

she has been transferred to a women's prison.

A repeat offender, Jackie Farrell, 35, has been in and out of several New York prisons. According to a corrections department spokesman, some of those sentences were served in men's prisons and at least one was served in a women's prison -- Bedford Hills, near New York City. Spokesman Jim Flateau said that the assignments to different gender prisons came because Farrell's arrest reports, furnished by the New York City police, sometimes listed her as a man and sometimes as a woman. She claims to have had a sex change

when she was 18 years old.
In 1985, Farrell was sentenced to three and a half to seven years in prison for robbery, her most recent offense. At that time, corrections department officials sought an independent determination of Farrell's gender, and had her examined by a panel of university medical and psychological professionals. Although she presents the appearance of a female, Flateau said, the experts determined that Farrell was most suited for a male prison. She was incarcerated at the Clinton Correctional Facility. That was where the Clinton Correctional Facility. That was where Farrell charged guards molested and harassed her and forced her to have sex with them. This formed the basis for her suit. Flateau said that transgendered inmates such as Farrell

who have medical authorization can receive female hormones at state expense. He also said that if officials determine transgendered inmates are "victim-prone", they can be placed in voluntary or involuntary segregation to protect them from other inmates.

## TS FOUND MURDERED AT PHILLY CONSTRUCTION SITE

(Philadelphia, PA) -- Three days before Christmas, the body of a 26-year-old male-to-female transsexual was discovered in Center City Philadelphia. She had been stabbed several

times in the chest and stomach.
A security guard working for Thomas\_Jefferson University Hospital discovered the body of Anna Francisco on the morning of December 22 on a hospital construction site near

11th and Walnut Streets.

Police say that Francisco was killed at or near the site.

They had no motive for the brutal murder nor suspects.

According to her friend Joanna Sylvester, Francisco worked in the home health care field and was studying to become a nurse. She had planned to undergo sex reassignment surgery within six months, Sylvester said. She lived with her family in the Feltonville section of Philadelphia.

"She was a sweetheart -- gentle," Sylvester said. "She never hurt anyone. Her only mistake was being a pre-operative transsexual. Why was she murdered? I am sure it was a crime of hate because of her true gender."

A \$1,500 reward has been offered for information leading to the arrest and conviction of those responsible for Francisco's murder. ["Renaissance News"]

national board has officially asked the chapters in South Jersey, Lower Susquehanna Valley and Greater Philadelphia to 'adopt' the former Reading members for the unexpired portion of their paid membership.

The South Jersey chapter has agreed to Sinclair's request; the other chapters have yet to act as of this writing.

One of the problems associated with the disestablishment

is that there are no membership records that would show who had paid dues to Reading and when. This situation is not likely to occur again thanks to the new four-part membership form used by all the chapters, Sinclair said. But the lack of information about former Reading members makes it difficult to provide services to them. She asked Reading members to send whatever information they have about their dues payment to the national office, and promised that every effort will be made to treat those members fairly. The board estimated that the Reading chapter numbered

about a dozen members.

## TRANSSEXUAL ACTIVIST DIES OF AIDS

(San Francisco) -- Louis Graydon Sullivan, an author and female-to-male transsexual, died March 2 at his home here from the complications of AIDS. He was 39

Sullivan gained widespread notice last year for his book "From Female to Male: The Life of Jack Bee Garland", the story of a turn-of-the-century female crossdresser who worked as a woman journalist in Stockton and San Francisco and later served as a male in the Spanish-American War.

He was the founder and director of FTM, the first and only

international support group for female-to-male transsexuals. Researchers have estimated that about one in 50,000 females is a transsexual, compared with about one in 20,000 men who

made the switch.

Sullivan was a regular speaker at the Institute for the Advanced Study of Human Sexuality in San Francisco and a frequent contributor to the national gay publication "The Advocate". He was active in the San Francisco Gay Historical Society and was also closely involved with ETVC, a 400-plus member transsexual and transvestite support group in San Francisco.

Sullivan is survived by his grandmother, mother, a brother, two sisters, and six nieces and nephews. A memorial service was held March 15 at the Neptune Society [\*Chronicle\*] Columbarium. Interment was private.

## MAN UEARING DRESS FOUND SHOT IN HOLLYWOOD

(Hollywood, CA) -- A man wearing a dress was found shot to death on a street near Paramount Studios and detectives believe he was killed elsewhere and then dumped in the roadway, authorities said.

The victim was found on the pavement in the 400 block of North Windsor Boulevard about 9:30pm February 18, Detective Ernie Basset said. The man, about 30, was dead at the scene from multiple gunshot wounds, Basset said.

The victim carried no identification. He was later

identified through fingerprints, but his name was withheld until relatives could be notified. ["Times" ["Times"]

## UELL-KNOUN TS ENTERTAINER FOUND MURDERFO NEAR NIGHTCLUB

(Memphis, TN) -- Police have no motive for the November murder of a well-known transsexual entertainer. The body of Michelle Maree was found not far from the Club Tiffany, where she worked as a waitress.

While robbery is a possibility -- her purse was missing when her body was discovered -- some members of the city's

gay community speculate that since she was working in a straight club, a patron may have gone off on a murderous rage when he discovered her true gender.

Haree was 40 years old and had lived as a woman for many years. She won the Miss Gay Memphis crown in 1973, and for the past two decades had performed in most of the gay clubs in the area and organized many benefits shows. A tribute and benefit show was held after her death to raise money for funeral expenses and to purchase a headstone.

## THE HIGH COST OF DOING BUSINESS

I'm writing this on the last day of the IFGE convention. Only trouble is, I'm in my office in Van Muys, not in my hotel room in Denver.

I don't want to sound egotistical in saying this, but the fact is that I am considered to be one of the national "leaders" in the gender community, due mainly to my membership on the Tri-Ess board of directors and my being the publisher of this newsletter. Yet I was absent from what is generally considered to be the "working convention" of the community — the week in which the majority of our business gets done.

And that upsets me, because I should have been there -- I would have been there -- except for the expense.

I'm not going to restate the economic problems we've had here of late. Those are obvious to anyone who has seen how our publication dates don't match the month on page 1. But that's not even the major issue here.

The cost of attending just one of the many conventions that take place each year is approximately equal to what the cost of publishing "Cross-Talk" would be if it had five times the subscribers it does. By the time you add airfare, hotel room, registration and meals together, you're in the four-digit range. And that's a prohibitive cost, even if

you're fortunate enough to have a decent income.
There are a number of people who, like myself, are considered to be the "movers and shakers" in the community. The ones that instantly come to mind are Merissa Sherrill Lynn, Virginia Prince, Jame Ellen Fairfax, JoAnn Roberts, Sheila Kirk, Janice Rupard, Wendy Parker, Wendi Danielle Pierce, Karen Baumgardner, Janice Van Cleve, Bette Lee Johnson, Renee Chevalier, Naomi Owen, Ellen Summers, Eve Burchert, Yvonne Cook ... well, you get the idea. How many of these people either were unable to attend IFGE, or if they did attend did so at significant financial hardship? I'd bet over 75% fit into one category or the other. It has often been said that as a community we seem to be

disjointed -- that the disparate points of view expressed by our national leaders seem to contradict each other, or at the very least have significant differences between similar statements. I have also heard it said that we never seem to have enough cohesion to move forward on the important issues of our community, such as civil rights, uniformity of terms in presenting our case to the public, and the conflicting agendas between the different "neighborhoods" (TV, TS, T6, etc.) within the community.

I don't believe we'll ever resolve these issues and create a unified gender community so long as we are unable to have a real consensus among the people we look to for leadership. If the "Coming Together/Working Together" conventions are to really be our annual opportunity to get the community's business accomplished, then the community must take steps to

ensure that the decision-makers can all be present.
I propose that there be a fund set up at IFGE, that any group or individual within the gender community can contribute to, that would be specifically earmarked to cover the expenses of our national leaders' attendance at the IFGE convention. If a leader feels he or she can attend without personal financial hardship, then I know that leader will take it upon himself or herself to leave the fund untouched. Our national leaders, by necessity, have a high degree of moral responsibility to the community, and I believe we could rely upon that. But if part (or all) of a leader's

## ALL RIGHT, OUT OF THE CLOSET ...

The phrase "mainstreaming transvestism" has been ricocheting around the inside of my head lately. I'm not quite sure what I mean by it, but it sounds good. I'll tell you what it doesn't mean, it doesn't mean getting every guy and his brother dressed up in crinolines and lace. I think what it means is what I've been advocating all along, taking transvestism out of the dark recesses of the closet and exposing it to the bright light of day. It means doing what is necessary to bring acceptance and understanding to what

we are and do.
Sounds all well and good, doesn't it? So, where's the problem? The problem is that transvestism is a term that describes a behavior without differentiating cause. It used to be that anyone who had a tonic-clonic seizure was termed epileptic. Now we say they have a seizure disorder, leaving the cause open for exploration. I can think of three causes of tonic-clonic seizures right off the bat. So, how do we differentiate the causes of transvestism, and does it really

matter?

Well, yes, it does matter. Because if we say X is the cause and J.Q. Public meets a TV who tells J.Q. that Y is the cause ... well, J.Q. becomes more confused instead of less confused and that doesn't help our cause. So, let's be honest, even the experts admit that there are several types of transvestite. Look through the literature if you don't believe me. Pseudo-, true, fetishistic to name three. Experimental, four. So if we are going to try to "mainstream transvestism" we're going to have to make it clear that there are indeed several types. How do we differentiate? Well, I think most of us know what category of TV we are. Does it matter? Yes. Rightly or wrongly, fair or not, some forms of transvestism will have a much harder time gaining acceptance than others; however, once one form is accepted

it will be easier for the others to follow.

To put it bluntly, and this is my opinion, society will have an easier time accepting those of us who have gender focused need to crossdress than it will accepting those who have a sex focused need to crossdress. In other words, those of us who have a need to change gender roles from time to time will meet less resistance than those who crossdress to achieve sexual gratification. Blame the Puritans, not me. Americans have a lot of sexual hang-ups and if your sexual practices are out side of "normal" limits ... well, gay bashing is a pretty popular sport these days. See what I

So, what has all this to do with "mainstreaming transvestism"? The old military axiom is, "Pick your fights." Decide where you have the best chance of winning and focus your energies there. The more limited your resources, the more this holds true. And if you think about it, if J.Q. is walking down the street and sees a couple of TVs how is J.Q. going to know which type they are (assuming, of course, that both are dressed for the time and place)? Well, there are other ways of telling, but not necessarily by how they're dressed.

The studies also seem to indicate that the fetishists are a very small segment of the TV community (I read it

a very small segment of the IV community (I read it somewhere), and that too makes a difference. Anyway, let me get back to the idea of "mainstreaming transvestism".

What are the issues likely to be in our quest? Obviously people are going to ask, "Why do you do that?" or "Why would anyone want to do that?" "Are you gay?" "Do you want to become a woman?" You know the drill. "No, I'm not gay (unless you happen to be that too)." "No, you're thinking of a transsexual, I'm a transvestite. There's a big difference. I just play at being a woman sometimes." "Why do I do it? If I knew that I'd be a millionaire." #### DO WE HURT?

I found the recent ad for the Gender Alternatives League hopeful. The observation on those "minorities" to have achieved rights ahead of ours is true. I should add that the women's and gay movements borrowed heavily and directly from the true mythic, cultural and natural histories of androgyny, while even then denying them to men and non-gays -- who, if those histories are properly inspected, should be the natural first inheritors. It belongs to Transgender. The black and other colored movements are now showing signs of very slowly getting around to the fact that native Shamanism was/is founded in the dualism of gender in its priesthood, which modern "civilized" people of color had rejected.

In that last trend lives one of our hopes for salvation, because the rejection by those people of color was due directly to their own (and our) persecutors' alienation of us from our inherent ancestoral roots (albeit that for some born white those roots are more spiritual than physical). That alienation changed us! Our world community in this "safe and civilized" world has taken the shape of not what we are but what what others would have us be and say we are, even within organized groups that seem to turn commercial or become mothers' knitting meeting very quickly.

The wrong kind of socialization has happened. Instead of having the independent courage of our convictions as a third gender, our majority has weakly run to whatever high-profile option it saw as offering sanctuary, chopping and changing

as each proved a weak straw to grab.

It was natural the majority should identify with the gay and women's movements, since both were unashamedly impersonating us. Whereas most fail to see this fact, having grown up schooled in the histories of our way of life, I can't miss it, and find these born female or homosexual impersonators of our way to be sinister and sick, for their exploitation of our virtue while denying us our part in its

making.
Thus GAL looked hopeful -- until I read those four

overused words "I hurt no one". Hogfeathers!!

I see too much of "we don't hurt anyone" coming from people who, observing how they are persecuted and abused, form "self-help groups" and counseling organizations. For what? Is it not as much to hide away from the chance of "hurting" others by our existence as to hide from the hurt itself? Forget who began the hurt first. We DB hurt others because we ARE human -- and because other humans cannot handle hurt and pain well either, they hurt us. For the most part, it is the psychic/mental pain felt by those too weak to think for themselves, causing them to harm us physically,

but it's just as real. Have you ever observed the ponderous progress of a zealous saffron-robed Zen Buddhist monk? Trying to walk carefully, and filtering his food not against impurity but to avoid killing macrobiotic life? Such meek atonement is admirable

-- but that's all it is, atonement, because to exist at all he had first, when his father drained seventy glands of fluid to fertilize and egg and initiate his conception, to rob his own father of some days of life; then for the next nine months to rob his mother of some more time alive; and finally, upon fracturing the air with his first cry, murder a million or more little unseen lives. #### MAKEUP: A FOUNTAIN OF YOUTH

Would you like to look ten to twenty years younger? Well, first of all you need to be at least 20 years old (!?!) ... but over 50 is a more ideal age to try for a look twenty

years younger.

When applying eye makeup and rouge or blush, think of the when applying eye makeup and rouge or blush, think of the word UP. Dark eyeshadow that extends beyond the eye, if not applied in an upward direction, will drag the eyes down and make them look tired and saggy. Blush should start halfway to the middle of your face and extend upward into the hairline above the ear. And just by arching the outer three-fourths of your eyebrows, you can create a perky, more youthful look.

But what if your skin is saggy and everything kind of droops? The old solution was by using surgical tape to create a kind of temporary "face lift". Now there's a quicker, easier to use version which accomplishes the same result. It's a band that pulls your skin up and back, fitting neatly underneath your wig. The band only takes seconds to put on, although you can still use surgical tape and then use the band to lift the eyebrows and skin even more. These "face lift bands" come in five sizes; if you have trouble finding them where you live, contact me for more information.

Also, if your skin is droopy, chances are your lips are too. To change the downturned lines these lips create, simply line your upper lip a little fuller than usual and DON'T go all the way to the corners. Leave a fraction of an inch on both sides and drop the color sharply into the inside lip, rather than tapering thinner at the ends. Make sure the thickest part of the lower lip is in the center,

and connect to the corners where the upper lip color ends.
Fill in the "faked" lipline rather than the natural one.

## WHAT COLORS ARE RIGHT FOR YOU?

In selecting fashions a woman must consider styling, size, fit and color. Of these, color coordination may be the most important.

We all have our favorite colors and conception of what constitutes feminine colors, so we tend to select clothing in these colors. Not too infrequently, when trying something on we wonder why it just doesn't seem to be right.

It is a fallacy that only certain colors are feminine. All colors can be feminine. What is important is to coordinate the color of our clothes to the color of our skin, hair and

Coordination success also depends on the color of the light of the environment in which we make our observation. Some of these factors we cannot control, but happily, nature has coordinated our body features so that all that is left to do is determine what colors best suit us and surround ourselves with color coordinated clothing and the proper

lighting.

How does one color code clothing to skin, hair and eye color? Well, as you might guess, there are many more "experts" in the field of color coding with different opinions than there are colors in the rainbow. But many agree that everyone can be categorized into four color groups. And since nature was responsible for the distribution, it is only natural to assign each group to each of the four seasons: Summer, Autumn, Winter and Spring. In discussing color coding it is my intention to present a simplified composite of the experts with whom I have had some contact. The first step we can take in simplifying color coding is to eliminate the Spring group. In my experience very few women (and no men) may be classified as Springs. ## THE GENDER COMMUNITY: A POLITICAL AND SOCIAL DISCUSSION

SPECIFIC GOALS IN THE 1990'S Where we are going in the Mineties encompasses involvement, increased commitment, and an understanding kind of network

that can bring us together to discuss important issues. General issues such as political and Gender community involvement; specific issues like peer group pressure from

within the community that push people into hormones or reassignment surgery before they are ready.

It is also important to be mindful that we create a new kind of closet in which people hide in social groups rather than relate to the rest of society. We need to address the topic of the tension that exists from disparate goals among TV, TG, TS, and Gay communities. A kind of healing and understanding can be worked out by getting in touch with our nurturing and loving feminine side. We should work toward a realization that no matter how you think people perceive you, or how well you look that looks are not everything. We need to fight against the male oriented thinking of Madison Avenue's version of what women should look like. We should understand that 99% of passing is attitude and, in the Nineties, we should have a more relaxed and confident attitude. Let's not get sidetracked by the intoxicating atmosphere of living in a false alternative existence in which there is a real world and a fantasy femme world. One of the goals that I feel we should address in the Nineties is a "coming together" of the best of both sides of your personality in a unified and successfully integrated, relaxed portrayal to society.

Stepping through the looking glass, you often see the reverse image of yourself. As Alice, don't become a lost soul floating in Wonderland, but embrace the flip side of your personality without denying your previous history and its impact on your future plans. For those who make a life commitment by transitioning, it's not enough to purge your previous life by destroying photos and facts concerning you as a human being prior to transition. Instead, learn to love who you are as a person, which means coming to grips with who you were as a person. The notion of creating "new people" in some God-like manner has been written about from Pygmalian to Dr. Frankenstein. None of us have the omnipotent power of a deity to create new life. We do have

the option to alter it in an acceptably comfortable form.
There is a tendency in our community to take ourselves too seriously with a guarded ability to laugh at ourselves in life situations. With blinders on, we sometimes wallow in self-effacing pity as to how things might have been if we had been born into the right circumstance. When life hands

you lemons, don't just make lemonade, make pink lemonade. In the Nineties, we want to put the buck passing, finger pointing, shifting of responsibility past us and as "adult children" move on to accepting responsibility about where we are in life. We can go ahead with a sense of pride and doing the best we can to educate the public about who we are in a non-judgemental fashion.

I'm not suggesting that this will be easy, crossing the gender line. Reaction of the general public to crossing the gender line seems to go against the very grain of original birthright and, to some, contradicts the basic division of nature. It is therefore understandable that to the unenlightened, uneducated, and non-expansive thinkers on the planet that this phenomenon brings about a knee-jerk response that can range from quiet disgust to outright violent reactions. It's up to us to change those attitudes about gender choice for all of our sake.

It seems that anytime a celebrity has ever briefly touched on the subject of gender, it is radical enough for them to be branded for life. It's funny that after thousands of television shows, Phil Donahue is best remembered as the guy who wore the "dress". Film director Sidney Pollock has a long and distinguished film career, but the press refers to him as "Tootsie's" Sidney Pollock. Milton Berle has been him as "corredy burlessue for half a century but for most him doing comedy burlesque for half a century, but for most, his campy drag come instantly to mind. Pushing the gender envelope to the limits seems to call for more patient understanding from friends and relatives than revealing to loved ones that you are Gay or perhaps a convicted ax-murderer

Instead of making hand-wringing apologies to friends and loved ones, who should be pleased for our happiness, we should be proud of who we are without apology. I'm not snould be proud of who we are without applogy. I m hot suggesting jeopardizing jobs, careers, and relationships, but enlightened, loving people are not threatened by those who are different from themselves. On the contrary, for the most part, they welcome variety as the spice of life. I've wondered about people of the "Morton Downey Audience" variety who turn violently hostile at the mere notion that there are folks who are different from themselves. How arrogant they must be to assume everyone should be like themselves. As the Bible points out, who among us is so perfect that they have the right to judge anyone, let alone in a sarcastic or deprecating manner? By what right does

#### TALK SHOWS: HELP OR HYPE?

I recently was asked to appear on a television talk show. The topic was crossdressers and their wives/partners. Since I want to support women who are in a relationship with a crossdresser, I thought this would be a good opportunity to tell the public about the issues that face many of these women. I could not have been more wrong. If it had not been for my wife (who was in the audience) the viewers would have been left with a very unreal picture of such relationships.

The focus of the show was a real wedding where both the bride and groom wore (identical) wedding dresses. This is a fantasy for many crossdressers. There have been other variations on this marriage scene. For example, the bride wore the tuxedo and the groom wore the wedding gown. In addition to the couple who were to be married, there were two other couples. One couple had been married for many years and the other couple has been dating for about six months. All three of the women on the show were (or said they were) wholeheartedly in favor of their partner's crossdressing. Most of the audience questions were either about the reasons why a man would crossdress or asking why these women would want to be in a relationship with a man who wears women's clothes.

There were virtually no negative questions. None of the women voiced any problems or difficulties they had about the crossdressing. In sum, a very positive image was presented. When my wife saw the direction of the program, she addressed a question to me. "Are these typical relationships?" she wanted to know. This gave me a brief opportunity to explain that the majority of such relationships had problems. Unfortunately, this was lost in the excitement of the

wedding.

Later I reflected on this show, and others like it. I wondered if they helped or hurt the image of the gender community. Many crossdressers (and their partners) who go on such shows are in unusual situations. Often they are "out of the closet" with little to lose if their friends, coworkers and neighbors discover the man's desire to wear women's

clothing.

I suggest that perhaps the only positive thing about such shows is the contact number that usually appears at the end of the show. Otherwise, the image that is presented is one that misleads more than it helps. Can you imagine the feelings of some woman who is struggling with the issues raised by her partner's crossdressing when she sees this show? She will most certainly wonder why she is not as accepting as those women on that stage. She may see herself as somehow flawed because her feelings are so different. The crossdresser who views the show may use it as a way of trying to gain acceptance by saying, "If that woman can accept this, why can't you?"

So the show gets the fanfare but the people I am concerned about may be hurt in the process. This is not to argue that

we shouldn't continue appearing on such shows. This wedding was unusual. While it was very meaningful for the couple involved it did little to educate the public about the critical relationship issues that crossdressing often

creates.

This does not mean that we are the only supportive wives, because I personally know of many who support, but cannot or will not, for whatever reason, come to the meetings. And there are many wives who are not supportive, or who would like to be but are frightened.

How can we reach them? It is a very difficult thing to do because we cannot force them to accept their husband's needs, nor to understand why. The only course of action that

I can think of is twofold: 1. We must offer their husbands a safe, supportive atmosphere in which to express their inner feminine selves. By doing this it is likely that their inner pressures will be reduced, and perhaps their resulting calmness and serenity will become apparent to their wives as a positive change.

We must try by gentle means to educate wives. Many wives are willing to participate from afar by reading our newsletter, or reading letters their husbands receive from other crossdressers. Therefore we need to make sure that the material provided in newsletters and correspondence and other chapter material is appropriate

and useful for helping significant others learn.
We need to stress the positives of crossdressing, the sharing and friendships that develop. We need to try to clam the understandable fears they may have and concentrate on showing the beauty of the person within. The person within is always the same, whether dressed en femme or non-femme —-the inner self does not change. The clothes simply help to focus and project an aspect of that self that is not often shared. A crossdresser is simply expressing a need within himself to get in touch with a more feminine part of himself and the very real feelings and emotions associated with those traits which have often been deeply suppressed. Although these needs may seem different from other men's needs, and the outward manifestation of those needs may appear very different from standard male behavior, I cannot believe it is wrong. If we listen to many modern psychiatrists and psychologists they suggest that most men need to get in closer touch with the emotions that it is not considered manly to express.

If a woman loves the inner man, then she is loving the whole person, whether she realizes it or not. To be able to share the entire person is, in my mind, a privilege which I

do not take lightly.

So you just got all dressed up and have nowhere to go. Sure, you could try the shopping mall again, but that's only a few hours. Wouldn't it be wonderful to spend a weekend en femme? But the next TV weekend is months away and besides, it's halfway across the country and you can't afford it anyway. I have a suggestion for you then. I am as obsessed with folk music as I am with dresses, and all through the summer

months there are folk festivals scattered around the

months there are folk festivals scattered around the country. When folkies converge on one piece of ground for a weekend of music something remarkable happens. An instant caring community forms and you can let the kids run free while you browse among the music and crafts or just simply enjoy yourself without any pressure or hassle.

Say the words "Folk Music" and most people think of Woody Guthrie or Peter, Paul & Mary. But folk music is such more than that. In a typical festival you will find a bluegrass band, someone singing the blues, a bit of '20s or '30s jazz, an entire area devoted to the kids, close-harmony Gospel on Sunday mornings, bawdy songs around the campfire. Irish Sunday mornings, bawdy songs around the campfire, Irish sunday mornings, Dawdy songs around the camprire, irish tenors, British drinking songs in 95 part harmony, French love songs, a Yiddish klezmer band, a Scottish piper or a Canadian fiddler. In short, if there is not a long cord with an amplifier on the end you'll find it somewhere.

For the TV there are several advantages. Since it is the

last refuge of the hippie look, long hair, flowing skirts and ruffled blouses are in, even if we can't join in the bra-less look. It's outdoors and there are no dress codes, so you have a wide choice of clothing to wear. The only problem is makeup. Since we can't very well go without it would take some care; heavy makeup would be noticeably out of place unless backed up with suitably ostentatious clothing.

Many festivals have booths of striking and original jewelry, clothing and oddaments that are mostly made by hand and simply cannot be found elseware. You could stay at a motel, but as most festivals are held in the open there is camping on site or nearby and dressing privately in your tent or room is easy. The availability of portable toilets, while not the most wonderful of inventions, eliminates that vexing problem of which door to go thru when nature calls.

Most important, folkies are the original laid back crowd, and there is such an open and friendly feeling that even if you are read it will most likely result in some friendly and curious conversation with nobody getting excited. The cost for the weekend usualy runs less than \$30 per person and kids 12 and under are usually free. Most have food at reasonable prices or you can bring your own. Most festivals ban or restrict alcohol to designated areas; these are very

The best way is to send \$3.75 + postage (call it \$4.50) to Sing Out!, 125 E. 3rd St., Bethlehem PA 18015 and ask for their issue with the festival listings. You could even be a big spender and send \$15.00 for a subscription, it's a good deal. So widen your horizons and get out to see the world.

[Ed. Note: While the methods described in this article are based on California law, those living in other states will find the procedures similar.1

Common law is a de facto method that seems to work well for most purposes. If you are entering into transition -- that is to say, living full-time as a member of your gender of choice, you will shortly find that you will be needing a few pieces of gender appropriate identification.

The most common piece of identification is the driver license or state I.D. card. There is a relatively simple way to go about doing this. Because people get married and divorced all the time, most states have an apparatus in

place to expedite the process.

In California, DMV form 84-3 is a confidential medical information authorization for change of name and gender which can be picked up at any DMV office. This form calls for a doctor's signature, but I have seen it accepted with the signature of a social worker if the signatory is known to that DMV office.

Upon presentation of this form you will be issued a new driver license or I.D. card. It will be necessary for you to appear in the office in your new gender so your photo can be

taken.

The catch (there is always a catch) is that you may be asked for a picture I.D. so as to demonstrate your identity and thus prove that you are the person the form refers to.

The simplest way which I have found to achieve this is to go to your public transportation company and apply for a

handicapped bus pass. In L.A., the RTD issues a disabled fare application which must be signed by a doctor or social worker, but which requires no secondary piece of I.D. to accompany it. The nice thing about this method is that the bus pass can be picked up in a day or two, unlike the driver license which takes six to eight weeks to arrive.

Returning to the latter, I should mention that you will be allowed to retain your old license even after you have received the new one. [Ed. Note: This exemption to the "one license to a person rule" only applies to transsexuals. Transvestites and transgendersists mist still surrender the old license or I.D. card if they wish a change of name.1 A word of warning: Don't go out with both pieces of identification or you may find yourself charged with attempt to defraud. One gender and one gender ONLY is all you should have on you at any one time, and that should be consistent with your gender of presentation. If you are still changing back and forth, perhaps for work, keep each piece of I.D. in the right wallet.

records into a closed file which is not available for public inspection. In this way, they protect your privacy. To get a printout of your records for insurance or other purposes, you will need to go to a DMV office and present your I.D. to a supervisor who will have the password to access your file.

With your new driver license or I.D. card, you can walk over to the Social Security office and get the name changed on their records as well as being issued a new card. This is just a matter of filling out another form. This time you will not need any signature besides your own. You will keep the same number that you have always had so there is no need to worry about a loss of benefits. Your sex will not be changed until after you have had SRS and present them with a letter from your doctor, but that information does not appear on your card anyway.

Don't worry about paying taxes with W-2s in two different names. The IRS doesn't care what your name is as long as

your social security account number is the same.

Next, you will most likely want to open a bank account in your new name. This you may do with your new I.D. just as you have done in the past, or you may want to put an AKA on your existing account. If you elect to do the latter, you will be able to cash or deposit checks regardless of which name they may be made out to. Names on your checks may be anything you want ... either or both. You may wish to have checks printed in two sets, one for him and one for her. It is up to you; whatever you think would work best for you, the bank will do. They just want your money and really don't care about gender issues.

Credit cards may be the easiest thing of all to change. What many people have done is to simply have the card company issue a second card on your existing account, as they would for a spouse. In this way, once again you have a credit card for both genders. How convenient. If you do not use your male card and always pay your bills with checks printed in the female name, in time you may want to change the name on the account with a history of payments in the new name already established. You then bypass any trouble that the lack of a credit history for your new name may present.


Once you have done these things, maybe also taken a class at the local community college (getting an I.D. there also), you are well on your way to establishing a paper trail that the new person exist. Other things may be a phone book listing, a change with the utility companies, and receiving mail. After about a year, you are who you now call yourself and the old you is almost gone.



You want to be careful about revealing yourself if you decide to go public because some become hostile, or at least passively aggressive, if they are confused. You upset their frame of reference by telling them that black is white and up is down. A lot of folks become very defensive about this. The same holds true if they perceive someone anatomically male their entire life, who suddenly declares himself female as a gender choice. By confusing their frame of reference, people aren't able to peg you into a convenient slot and the kind of defensive hostility, bigotry, or social ostracism that results can harm jobs, relationships, and the tranquility of life in general. The solution is educating the public to separate concepts of sex and gender as the difference between what's between your legs and what's between your ears. Our concept of how people view themselves is their business and there is no rightness or wrongness attached to it.

In the Nineties, if a young girl envisions herself as an athlete or future U.S. president nowadays no one balks, but the young boy who envisions himself as a dressmaker is in trouble right from the start in our nervous, homophobic

society. To educate the public takes time, effort, and a desire to change things.

My hope is that this article is provocative and controversial enough to stimulate open discussion as to how we might further our goals. For the futurists among you, speculate on the various dynamics of role expectations in the future, a future in which women take on more responsibility and equal pay. This is a sensible approach to living. My hope is that the discussion will also include common goals of the Gay, Lesbian, D&S, TV, TG, and TS community and how we can all work together instead of working at opposite ends, diluting the strength that we do have.

Merissa has spoken of a long term goal in the Nineties to encourage the professional community to have transvestism and transsexualism removed from the Diagnostic and Statistical Manual of Mental Disorders. The Gay community had themselves removed from the DSM and we hope that we'll be off of the list as well. By doing this, we will help to de-stigmatize our group.

Determining your season may not be easy, but it can be fun. You may already have an inkling of your season if you have an extensive wardrobe and you can identify some of the outfits as always looking good on you and drawing compliments from friends, while other outfits make you feel

uncomfortable without exactly knowing why.

Your clothes, particularly upper body garments and hair,
provide a frame for your face. Your face, aided by makeup, provides a frame for your eyes which should be the focal point of your person. The eyes are usually the initial contact point when encountering another person and they should be the focal point of contact during a conversation.

The color of your eyes should be your most dominant feature in determining your seasonal group. Analyzing eye color under natural light conditions is a good activity for a small group. Have each person observe your eyes and write down the impression of the color they see. You may want to repeat this under different lighting conditions. Hopefully you will get a majority opinion.

The following eye colors are categorized according to seasonal groups:

**AUTUMN** SUMMER VINTER Light Blue Clear Blue Dark Brown Black Deep Blue Hazel Bluish Gray Reddish Brown Amber Pale Green Dark Green Greenish Gray

In addition to eye color, your natural hair color may help to determine your seasonal group. The following hair colors are categorized according to seasonal groups:

SUMMER Ash Blonde Strawberry Blonde Silver Gray

AUTUMN Reddish Brown Auburn Ash Brown Chestnut

WINTER Dark Brown Black White Frosted Blonde

This table can be used in reverse; once you have determined your seasonal group, you can use the table in selecting a wig color.

Proudly, I have never regretted this childhood of mine, and have always considered the plastic bracelet to be a gift from an angel, who sent me of on a path to discover the life I now live. Besides my clandestine desires to be a girl, other curiosities had ripened, that I guess weren't typical for a teenage boy.
