Congress of Reps creates ByLaws, pens accord with IFGE

The Congress of Representatives and the IFGE board of directors have finally agreed on the autonomy of the Congress. An agreement for services between the two organizations is expected to be signed by Alison Laing, current Chair of the Congress and IFGE Chair of the Board, Wendi Pierce.

Laing, at the request of Pierce, developed a series of documents for the Congress including By Laws, a Summary Statement and a Reciprocal Agreement. The Reciprocal Agreement is the important document for IFGE. It stipulates that IFGE will provide space and logistical support for an annual Congress meeting at the IFGE annual convention and assist the Congress in disseminating information of interest to member organizations through IFGE's *Update* newsletter. In return, the Congress will assist

IFGE by providing nominations for various IFGE offices and awards, plus assistance in developing programs for the community.

IFGE will assign a staff member as liaison to the Congress so that Congress concerns get visability at IFGE headquarters. The Congress has also asked that a member representative be allowed to attend the annual IFGE meeting.

The Reciprocal Agreement in no way obligates the Congress to an exclusive arrangement with IFGE. In fact, according to Congress staff, they want to hold Congress work group meetings at events other than the IFGE annual convention. Both Fantasia Fair and the Texas "T" Party have been mentioned as possible sites for work group meetings.

Even though the two chair persons will sign the agreement, none of it holds any water until the com-

munity has a chance to review and ratify the By Laws for the Congress itself. As far as the community is concerned, the By Laws is the most important document. It defines the Congress as a not-for-profit organization with no fiduciary or legal standing. It defines the purpose of the Congress to promote and encourage diverse representations of our community and to facilitate communications within our community and the community at large. And, additionally, it specifies membership requirements for the Congress.

More importantly, the By Laws do not link the Congress to IFGE or any other organization in a way that makes the Congress dependent on that organization for its existence. As long any support groups exist and are willing to appoint representatives, the Congress of Reps will exist.



Library Almost Ready.

Soon the day will come when a transgendered person who needs information can walk into one place and be able to look at a large collection of books, tapes and news clippings. Magazines and group newsletters will all be there to give the searcher any information they require.

This type of library exists already in some lucky parts of the world but up till now this area was forced to do without. Now, after working on the idea for a couple of years, purchasing a locking cabinet, gathering a collection of books, magazines and clippings, at long last it's almost ready to open.

I say almost because now the new Librarian, Laura Edwards, is hard at work Dewey decimalizing and organizing the mass of info that we have compiled. Laura has decided to arrange all the hard back books first and then work on making other materials in the collection available.

"It's important to inventory what we've got and get it in an order that will allow people to find things, "Ms. Edwards said to staff reporter.

The Library case will be in an accessible area of the GPC meeting site. Materials will be available during meetings. Right now it will not be possible for members to check something out for an extended period. Everything must be returned to Laura before the end of the night. To insure that things do return it will be the Librarian's duty to obtain something of value from the borrower. After approving the minutes of the last meeting and hearing the Treasurer's report, local Chapter Leaders gave their reports.

One big topic was Newsletter staff changes. JoAnn handed in her resignation as a staff member and Angela read our former editor, Paula Jordan Sinclair's letter of resignation into the minutes.

Diane Farley presented a plan to get chapter information on cable television systems. She has already gotten the South Jersey Chapter listed on cable companies in their area and so she was appointed to coordinate cable outreach efforts throughout the local chapters.

Also in the outreach area was a project that Angela has been working on for some time with the aid of Dr.William Stayton. While not a member of any type of organized religion herself, Angela recognized the fact that many transgendered people are part of the congregations of many churches in our area. With Dr. Stayton's help she has come up with a letter that will be sent to area clergy, informing them of the existence of organization and the likelihood of TG people in their flocks.

Packets of information will be sent to clergy who respond to the letter by returning a response card. The information will include copies of articles on transgenderism and religion that were assembled by Ann, a member who has been with group for many years.

The Library was discussed and Beth Marshal presented a few of her ideas on how to improve our internal communication.
