Hello girls, this is Barbara back with some more insight. Last month I said that we would address the issue of fear this month, the fear that we must overcome in order to tell our wives or girlfriends of our feminine side. What is fear? Well Webster's defines it as painful emotions excited by apprehension of impending danger. Fear is a rather strange thing. Many of us have been in combat, W.W. II, Korea, Viet Nam, or Dessert Storm; yes wewere afraid, and I think it was because of that fear that we were able to return. It prevented us from letting down our guard. But the fear that we faced in combat or any otherdangerous situation just cannot compare to the fear that we face in telling our wives, our girlfriends, our parents our..... about our crossdressing. What is worst is the fact that our fear is self perpetuating, it is our fear itself that keeps us from overcoming our fear. What is there too fear in telling someone of ourfemside. We fear hurt on their part, rejection and ridicule.The rejection and ridicule I think is what makes the fear of telling so uniquely different from any other fear that we may experience. Any of you who have been thru a divorce know the pain that is felt. I think it is a pain that is most similar to that which we

fear will occur in telling that someone close about our femside. We desire love, and we desire to beloved, and we fear that we will lose that love that we cherish and desire. Ridicule, our society has not yet fully come to accept the idea of men dressing as women. We fear becoming the butt of the town gossip. Many of us are in a professional position and we fear that the ridicule will lead to loss of social and financial status. We fear being looked upon as someone less than It is these things we normal. fear that makes overcoming our fear so difficult, and yet we MUST overcome our fear of fear if we are to overcome that which we fear. What is worst is that our fear causes us much mental anguish. As crossdressers we are people very strong infeelings. The inability to share those feelings with those we love, the need to keep those feelings secret, places anextra heavy burden on our mind. How much easier would it be to overcome our fear if we could reasonably predict the outcome from telling someone about our femside. If we could gauge the persons reaction, then we have a resonable idea as to if that person will accept. The major problem here is that our fear has already caused us to make biased prediction against telling the one we love. In order to make a resonable prediction we must put aside that bias, and become observers. There are a number of ways we can use to gauge a persons reaction. One way would be to watch some of the talk shows like Sally Jessie

Rafial, or Jenny Jones and then to discuss the topic of the show with the person that we wish to tell about ourselves. By discussing topics other than that of crossdressing, we do not tend to lead suspicion as to our motive for the discussion, and tends to give us an idea of that persons attitude to all people of difference. If there is reason to believe that a person will be acceptant of crossdressing, it is that they are open minded enough to accept people of all differences. Another tool that we may employ are things like dressing for events like Halloween or Mardi Gras, or crossdressing for bedtime fun. Of course these kind of things can only be doneif you are one know to do things just to be somewhat silly at times. If you are one who is always serious, never doing anything just for a laugh, then there will be cause for suspicion. How well educated is your wife? It has been found that the better educated a woman is the more likely she is to accept your femside, but at the same time, many women who have an average or less than average education have been just as accepting. My own wife has never completed high school and yet she is very accepting and sometimes even helpful. We must of course be mindful of the "this kind of thing only happens to other people, never in our family" concept. This is the big shock, and the deeper we are into the relationship with a wife/girlfriend, the bigger the shock. With parents there may be the tendency for self blame, a

desire to know what THEY did wrong. Children pose another problem which will be discussed in a near future column. For the time being let us concentrate on telling the wife/girlfriend. Perhaps the biggest factor in determining if a wife or girlfriend will accept will be the condition of therelationship. IT MUST BE ON SOUND FOOTING! While things like ultra conservatism, personal bias, religious and family upbringing will play against us, if the relationship is sound and there is nothing that would make her otherwise considerending the relationship, then the chance of acceptance is far greater than the chance of rejection. If there areothers problems in the relationship, then THESE MUST BE RESOLVED BEFORE THE INJECTION OF ANOTHER CRACK! Of utmost importance also will be your attitude AS A MAN towards women and women's rights. Do you help in the house, do you encourage your wife to be all that she can be, how well could you accept the concept of her being the majorbread winner in the household? If you do not consider her to be truly equal to you, then there is little likelihood thatshe will accept your Your chances of femininity. beingaccept really are dependent on how you treat her, not only asa wife, but as a person. If you have always treated her asan equal, than you really have nothing to fear, but if youhave treated her second class, then how can she understandyour desire to be like one that you consider to be of a lowerclass of

being than you consider yourself to be? How should we tell our wives? The operitive word hereis GENTLE. While no matter how we opt to tell there will beshock, we should do all that we can to invoke as littleshock as possible. I myself prefer the idea of a letter. The written word allows us to think out our exact wordingbeforehand, and we are unhampered by questions or the shockof the person we are telling. However this is not the only method, use what is comfortable for you. What should we say? Here compassion and concern forher. and our own education as to why we crossdress will bethe rule. Of utmost importance will be that we also conveyour feeling of love for the wife/girlfriend, AND THAT OURLOVE FOR HER IS UNCONDITIONAL to her acceptance. We must recognize that our wives also have fears. Her first and biggest fear that she will have in finding our about our femside is that we are gay or that we are planninga sex change. She will view our crossdressing as a threat to the security of her marriage, and one which she will have no weapon that she can fight back with. We must calm this fear, and show her that our being crossdressers does not mean weplan to leave her for another man or to becoming a womanourselves. If we are to have any hope of her accepting our femside, we must show her that our femininity is an extension of whowe are, and is what makes us the person that we are. As Ihave said before, to

me femininity represents gentleness, itmeans being compassionate and concerned, loving and kind, andabove all caring about others. Are we this when we aredressed as males? If not, it will be difficult to show herthat our crossdressing is a tool used to improve ourpersonality, to make us the type of husband that she can beproud of being married to. She will fear that her children will also becrossdressers and she will fear her own rejection by friendsand family. These are also issue that will have to beaddressed eventually, but they are not the major concern atthis time. There are a number of good books on the market todaythat will help your wife to better understand this phenomenonof crossdressing. Having one or all of them prior to tellingthe wife is highly recommended. At the end of this column Iwill provide you with a list of those books and where toobtain them from. In the end I think the real tool to eliminating our fearof telling our wives or girlfriends of our feminine side isself education. Educate ourselves about our owncrossdressing and our need to crossdress, and most importanteducate ourselves about our wives. Learn her feelings, andlearn her fears. Once we know her feelings and her fears, wecan prepare ourselves to address those feelings and fears.Perhaps the one biggest thing that will be done in tellingour wives/girlfriends about our crossdressing is that we willfurther open the lines of communications between our

wivesand ourselves. Once we open those lines completely, we willbe able to discuss the issue without fear. Well that is all for this month. Do take care and begood to yourself. YOU are worth it. I love each and everyone of you girls. Now below are some good books to use in aiding your telling your wife of your femside and where and how to obtain them. I highly recomend all of them for your own personal library.

New thoughts on Issue 3 and the pending lawsuit. I predict the repeal that was passed by the voters in November will be over turned in court. Not because the court agrees with the original ordinance passed by city council, but because the repeal was so poorly written. You see, the authors of the repeal were so hung up on the "sexual ordination" issue, that they didn't take the time to think through their actions. They claim the issue was "special rights". If that was truly the issue, then they should have fought to have the whole ordinance repealed. Instead they singled out only one group that is named under the ordinance. By doing this, they discriminated against that group by saying, what's ok for one party, is not ok for the other. Thus the repeal itself is discrimination, and not permitted under state or federal law. There's no question about it. Especially now that a court in Colorado has ruled on a similar case and set precedence.

One individual always comes to mind when I hear "discrimination." And that would be Heather, the founder of Crossport. When she started living full time, her boss fired her because of the gender change. Feeling down, she took a blue collar job at a Hills Department Store. As soon as they found out, she was told that she could not use the rest rooms in the store. (among other

things) After much hassle she quit. As her confidence and determination grew, she went for a good job in a small office. In no time, she was making more money then when she was a man. Again, the office found out. But this time she had proved herself as a valuable employee, and the owners loved her. A law giving her the "right" to work in her chosen gender was not needed. She not only became a better and stronger person because of her early experiences, and now she knows that they want her for her ability, not because some law says that they must hire her.

I actually think the original ordinance, as written, was rather self-centered, self-serving, a selfish document. I can think of dozens of afflicted individuals who are discriminated against everyday in all walks of life. For example; because of your appearance, or maybe your overweight, too old, too short, uneducated, speech or hearing impairments, and on and on. Who speaks for them? Doesn't everyone fall under the term "Human Rights"?

About 2 years ago, when this ordinance was first being drafted. I contacted those individuals who were having regular meetings on this topic. I told them as an individual who represents the gender community, I would like to be involved in it's drafting. I explained that the term "sexual orientation" did not really apply to Transvestites and Transsexuals, that sex and gender were different. And that in many cities where a Human

Rights Ordinance was adopted, we were included under the term "Gender Preference". I gave them all the information they needed to contact myself or Crossport. They not only showed no interest, I would never hear from them again.

Of all the documents I have seen on this subject, the Minnesota state statute 1992, section 363.01, subdivision 23, was the best to date. It includes both gay and transgender individuals, and does so on a state wide level. The girls of of Lakes CLCC (City Crossgender Community) worked months getting the wording just right. If I would try to get legislation passed in my state. I would use it as a model. I don't know why people waste their time and money on a city or county level.

By the way, if you read your Tapestry, you probably know that IFGE is working with the International Conference on Transgender Law and Employment Policy, Inc., on many legal issues that do effect all transgendered persons. Because of their 501(c)(3) tax status, IFGE cannot directly be involved in a political forum. However, the ICTLEP, which is made up of many qualified gender bending attorneys, and led by Phyllis Randolph Frye of Houston, is active working on many projects, which include future national legislation. Areas of focus are on employment law, health law, and military law

Bob spoke of how the gays in San Francisco fought an ordinance against crossdressing in the early 50's. Was this done to help the gender community, or was it because it interfered with their lifestyle? While Bob's intentions are well and true, I'm not about to bestow an award to the gay community for their efforts to improve our lifestyle.

He said, "what affects Gays also affects Crossdressers". Well then, would the Human Right Ordinance have had an effect on Heather's job problems? How is being gay anything like being transgender? Our only common ground is the fact that we're both minorities. Even putting on a dress doesn't count, because we both do it for different reasons. Our agenda's are different, theirs is sex, our's is gender.

Then on the other hand he's right. For a transsexual who is struggling to survive in the real world, crossdressing is a serious issue. Quite the opposite of most Drag Queens. This reminds me of an occurrence at 1470 West in Dayton years ago, when many of us went there on a regular basis. A group of gay men in drag came into the bar and made a scene. The following week, the owners enforced a new rule that no one in "drag" was permitted in 1470, except on Sunday night. The gay men who made the trouble were welcomed back, but all of your TV & TS sisters, including myself, were refused admittance. A few months later, Heather met the owners in private and finally worked it out so we could return. So I guess you could say that, the comportment of one party, can have an effect on the other.

Bob called "Special Functions", great support groups for Crossdressers. I think not! The very small number of us who do attend such events, is not for reasons of support. We are just out for a good time like everyone else. Knowing that the proceeds go for a good cause make it legitimate.

Joyce lumps Crossdressers together with Gays and speaks of the "Good old days', when we as Crossdressers had to fear walking the streets, less we be molested or arrested for trying to be ourselves." We never "had to fear" anything. Through groups like Crossport, the general public may now better understand why we dress, but the fear she spoke of is created in one's mind. For those transgendered individuals still in the closet, their fear is as real as ours was, years ago. What Crossport did, was provide the grounds for interaction with more experienced CDs, that gave the newcomers confidence by showing them that 99% of the things they feared never existed. Like a child who fears the first day of school or the mysterious light he sees on the wall of his otherwise dark bedroom, fear is created because of the unknown. Fear of the unknown is part of human nature. Fear of death is the reason Religion exist. Think about it!

Joyce also states that "discrimination against one group eventually leads to discrimination against all". Discrimination is not passed around like the flu. It is a learned social behavior. Education is the cure, not creating new laws. It's up to us. We all have a moral obligation to improve the sphere in which we exist, and return knowledge

to that entity for future prosperity.

Some of you obviously take me as a bigot, and in fact, don't even understand where I'm coming from. Truth is, I do have few minorities in a my employment, and always have. controversy by Stirring discussing current affairs keeps us on our toes, and in reality with how the real world views us. Besides, Miss "I told you so's" opinions and predictions are many times based on articles read in the gay newspapers pick up locally, that carry national news.
