COURTROOM

vs. TV/TS

PART THREE:

Perhaps responding to the sympathetic parties before it, the court responded knowingly and empathetically to the situation of transsexuals. The court reached a similar decision in the case of Doe vs McCann, 489 F. Supp. 76 (S.D. Texas 1980). This case provides a good example of a judge attempting to understand and describe the nature of transsexualism (distinguishing it from transvestitism) and the necessity to address it through surgical procedures. The court deemed that since transsexualism was not a matter of choice, a transsexual cannot be subject to criminal prosecution for actions that are a matter of medical necessity. Other than displaying general empathy for transgendered persons, these two decisions would not necessarily extend protection to transvestites.

A lower Ohio Court has likewise

held that the particular situation of transsexuals creates a judge-made exemption from prohibitions upon wearing clothes of the "opposite sex." The case was that of Columbus vs Zanders, 25 Ohio Misc. 144 (1970). This court also discussed the nature of transsexualism at length and held that because of a "mental defect" the defendant could not be criminally responsible for dressing as a female (as a general rule of criminal law, a person cannot be held criminally responsible if his or her acts arose from a mental defect). This court did not base its decision on constitutional grounds.

By contrast to the above decisions, older New York cases hold that these types of statutes are valid (see: Annot., 12 ALR 4th 1242). Hopefully these courts will reconsider these decisions when next presented with these issues.

Although the laws and those who administer it are far from perfect, the cases discussed above do show that, on occasion, judges (even those we elect) are willing to reject popular prejudice and take a rational look at medical and social reality.


