For a hot and sticky month, it is good to see that many out and about. With the last two meetings pushing hard to get more than twenty, we didn't expect that many untıl October. On top of that, we had five new faces in the crowd Welcome to all of you

During the meeting, the main discussion concerned the Cross-Port phone situation Historically, the phone has been very important in that Cross-Port is one of the few groups in the country which provides a "hot line" support for those who need help now. Heather has been providing this support by herself as long as CrossPort has been in existence.

Heather has studied more that anyone else in Cross-Port the reasons behind why we do what we do and has an extensive library of research and outreach material to back her up This and several years of speaking at educational and public forums makes her extremely hard to replace.

The other main topic of discussion was brought up by Dana who came in from Indianapolis. She had with her several issues of the New Works News, a gay newspaper published out of Indianapolis. The headline of that publication read INDY BARS BAR DRAG

According to $N W N$, since the closure of the 21 Club and G G's (formerly the largest gay bars in Indianapolis), the drag queens, transvestites and transsexuals who would hang out there began frequenting some of the smaller gay bars. Three
of these bars, Our Place, Jimmy's and the Varsity had all come up with new dress codes which effectively ban cross-dressers from entering. According to bar management, this discrimination was started because of complaints from "regular" customers.

The newspaper came out strongly against the discrimination and also published letters to the editor from IXE by Kerry Gean, Sharon Allyn and Bobbi Alyson which outlined the forms the discrimination took The newsletter also sent a reporter to attend the regular IXE meeting to get a better idea of what cross-dressing is all about. Thank you New Works News' We all appreciate your stand We also congratulate IXE for the strong public stand they have taken

Fortunately, Cincinnati is blessed with a group called the Greater Cincınnatı Gay/Lesbian Coalition (GCGLC) This group goes a long way to relieve the stresses which spring up between various factions of the gay community CrossPort is a member of GCGLC and has been almost since we began. With their help, what has happened in Indianapolis will never occur in Cincinnati Susan Lovelace is our representative to GCGLC and Heather is the alternate.

Speaking of Susan, at the last meeting she mentioned to me that she would like to create an activities committee which would organize events in which Cross-Port members could participate For those of you who have been wanting new and different things to do (including weekend gatherings), this is your chance. ## Can We Talk!

Well, after a couple of months off I have returned and all the news is good. As Cathy reported last month, I started a new job the day after Memorial Day I am once agaın working with computers and making the kind of money I was one year ago and I am doing it as me (Heather) I was only on the job about three weeks when I had to go to our San Francisco office for a week, which is why I was not at the last meeting.

I am also writing for the Transsexual Voice and what little time I have had to write I spent doing articles for that publication. As part of my agreement with Phoebe my articles on
"Transsexual Issues:" will appear first in the Transsexual Voice then in InnerView.

On top of all that I have moved into my own place. My new phone number will be given out to any one who calls the old Cross-Port number for about two more months. After that I will not be takıng calls directly for Cross-Port so, if you want to reach me get the number now by calling. I don't plan to publish it as a Cross-Port number and it is not to be listed in publications.

Those of you who have been following my work history know that one year ago I was fired for dress code violations at my old job because I wore a skirt suit to work I applied for Unemployment Compensation from the state of Ohio and received it until it ran out in December. Shortly after that I received a notice that the company had filed a request for reconsideration. In February I had to appear before a state review board I was represented by a person from Legal Aid If I lost I would be required to repay the state all the money I received.

In June I received my Decision. The following is an excerpt from that decision I am printing it here for two reasons. First it is a positive step forward for transsexuals in Ohio and second it is one of the best written non biased statements I have read

Statement of the Facts.
In January, 1988 the claimant informed the employer that he had been under treatment with a psychiatrist and the recommended course of treatment was for the claimant to do, or work at doing, a gender transition, from male to female. The claimant informed the employer that he would begin to assume the outward appearance of a female by clothing changes, use of cosmetics and jewelry, etc. The claimant assured the employer that what he was doing was not for immoral or illegal purposes, but part of a recommended regimen for mental health.

The employer was not pleased with the situation because of the effect the claimant's actions might have on the remainder of the work force, both office and plant The claimant was told that he would continue to use the "mens" room at the work place and he was told that dresses and skirts would not be tolerated.

The situation of the claimant's continued work and the progression of the more feminine life style proceeded without any major incident. On May 31, 1988, the claimant was notified, toward the end of the work shift, that the blouse and slacks outfit worn that day was not acceptable because the blouse was of such
material that any observer could ascertain that the claimant was wearing a brassiere. The claimant was sent home before the end of the shift and told to change clothes, but since the shift was almost over the claimant was not expected to return to work that day

Claimant was ill the next two days and the employer was properly notified and the absence was excused for illness. On June 3, 1988, the claimant reported for work wearing a skirt, which was part of a feminine business suit. The claimant was dismissed for alleged insubordination and disruptive behavior

## The Decision:

The employer presented no probative evidence to establish any disruption of a magnitude which would justify taking someone's livelihood from that person. The claimant's activities did not go unnoticed, however, nothing major occurred The claimant did disobey the employer's prohibition concerning the wearing apparel, however the clothes which the claimant wore were not unreasonable or unsuitable for the work place. The dress code which the employer established just for the claimant was unreasonable and the claimant's violation of this specific code did not constitute misconduct in connection with the work, which would justify the suspension of the claimant's unemployment compensation benefit rights.

Under Ohio Law the company had the right to fire me even if it was unjust but this decision does say that at least in some of the cases, the company will have to pay for that right. It shows that as far as unemployment compensation is concerned, the company should have taken into account that this was an approved medical condition and that the fear of the company that "there might be trouble" was not just grounds for dismissal.

This I feel is a major step toward the day when the laws will also protect us from discrimination. If I had it to do over again I would handle it in the same manner however, each of you must decide the best course of action for you at your work place if you should decide to move in the same direction.

It has been a rough year it has required a strength that I received only from the conviction that I am a woman no matter what anyone else says or feels and that I have a right to live as such even if the laws don't protect that right.

I feel I got my job because I was willing to go out and interview even when it seemed hopeless just for the experience and as a means of
building my own confidence. I am sure there were times I was laughed at or that people made fun of me, but I always walked away with my head high, proud to be a woman

I am in the process of setting up a sub-board on "The Cosmic Express" computer bulletın board system, 317-685-8437 My new sub-board, "Arlena's Jewel Box" will be in full operation starting July 14, 1989.

For the time being, this sub-board wall be closed to the general public. It will be open to all cross-dressers, not just members of IXE. This subboard will act as a clearing house for information concerning cross-dressing. It will also offer the exchange of both public and private messages of sisters who have access to the system.

The main topic for discussion on the public message base will be all of the various aspects of our cross-dressing. Every sister will have the ability to express her personal views about her cross-dressing. The listing of the feminine names and marling addresses of sisters who wish to correspond will be another feature of the subboard It will be similar to the personal listings offered by the TV-TS Tapestry Journal and some other publications. This feature will allow the listing of special interests. Any explicit sexual content will be limited to the private 'E-mall' message base.

For a sister to gain access to my sub-board she will have to become a full subscriber to "The Cosmic Express BBS" This will cost only $\$ 2.00$ per month with a three month minimum. There will not be any charge for access to my sub-board after the subscription fee of $\$ 6.00$ is paid My complete feminıne name "Arlena Marıa Starchild" must be used as a reference in a message to the sysop before access will be allowed.

We try very hard to keep the costs down for those who attend the meetings. We ask for a donation with $\$ 3.00$ being suggested although many times people donate more, less or not at all, depending on their financial situation. It seems to work.
