WILMA'S VIEWS

THE AVERAGE CROSS - DRESSER:

H ave you ever thought what an average cross - dresser was like, what made him the way he is and what are some of the components that have made up his life and experiences? Well, I have often thought about this and adding together some interesting statistics that I have gathered over the years, I would like to relate the results. Because of having the oportunity to look at over 1,000 categories, I believe that I should put these facts together and see what comes out.First of all, I should state that I'm not trying to place anyone in a "pigeon-hole"as such, but merely trying to piece together what the average TV is all about. I should also state that using over three thousand applications, I can conlude, with a good deal of accuracy, what areas of development and likes and dislikes the average TV consists of. So with this bit of information as a prelude, let's see what does make up our "average TV".

He was first attracted to some article of feminine clothing, something "silky" about age ten. Before this age most TV's don't remember, but mant "recall some associated interest in "Femme-things" even earlier. He was one of 3 children and felt some degree of envy toward a sister, playmate or cousin a few years older than himself. This interest started from noticing the difference in clothing and to some degree, ignorance of the physical differences that made up girls. The curiousity grew to experimentation with articles that were readily available in the bathroom or laundry. Upon trying on something feminine, usually undies, an excitment resulted and a pleasing sense was felt inside. Experimentation with more than one article developed with an increasing feeling of self satisfaction at how he looked as a girl and about age 14, some trial cosmetics were used, mostly lipstick.

Development as a boy seems to be fairly average except a definite desire to prove "being a man" by participating of sports of all kinds. The guilt feeling usually became quite prononnced in the middle teens with constant purges resulting, such as "never to do it again". Also, a good degree of confusion became evident in the middle teens regarding weather our average TV was "Gay" or not. The feeling that he was the only man in the world that liked to dress as a girl and strong feelings of sexual attraction toward girls caused periods of depression which were ended by some masculine feet being accomplished.

Mr. Average TV started buying some intimate articles of feminine apparel in his late teens as money became available & his taste become more sophisticated. After high school he went into service; majority served at least 2 years with "dressing" oppotunities confined to leaves. The "desires" seemed to diminish somewhat while in the service, but become more pronounced once a civilian agaiN. Dating was frequent & Mr. Average TV was well accepted by the ladies, although his search for understanding from his girl friends regarding his femme desires took him to many different girls. He told at least 1 person of his desires, us_ ually a girl friend. The reaction of these "informed" people was mostly a "so what" type of thing, but little help or encouragement was ever realized, Mr. Average has 1 yr. & 1 semester of college education & is a business man or professional. The incidence of financial sucess seems to be about on the norm with most men. Mr. Average is 35 yrs. old, married(once)& has 2 children.

He didn't tell his wife anything about his TV desires before marriage, although a large percentage, nearly ome-third, did tel the wife-to-be, because he thought his urges would diminish or disappear after marriage. To his shock, the desire returned within a year of marriage & seemed to increase after that time. Secrecy was still maintained, but guilt, fear & depression built to a high level. Mr. Average TV went to see a psychiatrist for approximately 3 sessions within 2 yrs. after marriage, but was disappointed with the results & lack of knowledg on the subject. His pattern seemed to be one of buying complete feminine costumes, including shoes & some makeup. Dressing in these things whenever possible including business trips out of town.

After much agony with the realization that he either couldn't or wouldn't quit he told all or as much as he knew to his wife. This very tense occassion took place about 3 yrs. after marriage. The average reagtion by the wife to her TV husband is one of some degree of understanding. At least permitting dressing while she is not present & an occassional feminine gift was received. It is interesting to note that the early TVIC applications showed little acceptance by the wife & a helpful wife was usually the exception. With the last 500 applications averaged in, however, acceptance to a good degree is now normal and complete hostility is very much the exception. Our Mr. average TV is fairly stable now and is trying to integrate his femme desires into a normal, reasonably healthy life. There you have it: nothing really new or startling, but a factual account of just what TVism is about these days. The results should dispell much of the professional conclusions published in the past based on a few cases studies with extreme patterns of behavior. But for now our average TV looks very average and blends into the norms of the average male in society.

Dear Wilma, Why do I let you do this to me? First you hooked me into a chess game that could not be completed. Then you ask these Questions of the Month. Just when I think I've answered your Q of the M, along comes another issue of the journal and another batch of questions. It wouldn't be so bad if they were dumb questions. I just wouldn't bother answering them. But they are always thought-provoking. In the April issue, you wondered Does Wilma write too much about TS? No! What you write is of interest to both TS & TV people as well as their relatives. Does Wilma give the wrong impression about TS? Wilma gives HER impression. Joyce gives HERS. The reader can take or reject either view. Finally, Wilma wonders just what is a TS. We all wonder the same thing. No one has yet been able to define it well enough to make an early diagnosis to prevent it's developing into an incurable condition. A stranger recently asked me what is a ts, and I replied, "It's a woman who looks like a man." In simplest terms, there is truth to that definition, but it does nothing to aid in self-diagnosis. You might try a set of questions for self-analysis : 1. Did you feel - before the age of 7, that you want to be (or should be) the opposite sex? Did you do at least some cross-dressing at a very early age?
 Would you be willing to sacrifice EVERYTHING to get a sex reassignment?
 Would you rather be married to someone of the same biological sex as yourself, or someone of the opposite genetic sex? If all four questions seem absurd, you probably have no serious cross-gender identity problem. If the answers to all four questions seem to indicate a transsexual nature, then it is quite possible that you are TS. If the answers to the first two questions indicate a gender dysphoria, and the answers to the next two questions do not, you may well be TV. If only the first and/or fourth questions indicate gender confusion, you might possibly be homosexual. Any other combination of answers might point to the need for more extensive analysis. However, quickie tests are not very reliable. The best indicator that I have seen in my limited experience is the adult who is normal in most respects except for the all-consuming desire to be the opposite sex. Even in the near-absense of cross-dressing, such a person could be considered to be transsexual. Now let's take a look at your article on the international standards for treatment of gender dysphoria. You question the attotude that a complete reassignment on demand is contraindicated. Experience has shown that people seek mutilation for a variety of reasons including masochistic, psychotic and just plain whimsical. Some screening is necessary - not to discourage the honest transsexual, but to weed out the non-transsexuals. Consider the case that occurred just a few months ago involving reputable specialists with good intentions. The patient had brief psychiatric counseling and demanded full reassignment. After surgery, the patient complained that the doctors were too hasty with the scalpel and proceeded to sue all of the doctors involved in the case. A more thorough screening would have given the patient a better opportunity to consider the treatment before it had progressed to the irreversable stage. As to your opinion regarding the sequence of hormonal therapy and the "real-life" test, I concur wholeheartedly. The initial administering of estrogen to a male patient is an excellent diagnostic tool. It is also innocuous for the first few months. Furthermore, it is obviously requisite for a social gender change. A book could be written on this topic, but let the paragraph suffice for the nonce. Allow me to comment on one other item in that article. You proffered the concept of peer counseling and immediately dropped the idea with no comment. The concept is laden with both merit and problems. Where would we find our supply of post-ops who would volunteer their time, effort - and possibly their reputation to aid the novitiates. Some post-ops are highly trained specialists who could be helpful and de-

post-ops are highly trained specialists who could be helpful and deserve to be paid for their time. Others are just average people who want only anonymity and obsurity. They have neither the training nor the inclination to help the new post-op. What makes a post-op more qualified than a pre-op to render assistance to another TS? Why is the source of help limited to another TS? A compassionate TV could be helpful. An open-minded clergyman could be useful. Help could be found in a battery of lay experts including the cosmetician and the hairdresser.

The XX club of Hartford does provide informal peer counseling to the pre-op and the post-op TS. The Albany TVIC does its share. Boston has the Tiffany Club as a haven for all cross-dressers: male & female, TV & TS, pre-op & post-op. Other organizations throughout the country can and do serve as peer counseling groups. It is not within the scope of the international committee to require peer counseling as a professional standard.

- Now Joyce offers her own concept of professional aid to the cross-dresser. 1. When a cross-dresser seeks professional help, the first tagget is usually a psychologist or a psychiatrist. Every such doctor should know at least enough about the phenomenon to recommend a specialist.
- 2. Psychologists & psychiatrists who specialize in the treatment of the cross-dresser (and other sexual minorities) should be at least
- acquainted with the nearest gender clinic. Where indicated, they should refer the patient to the clinic for enrollment in a program that is designed to provide the optimal benefit to the patient. The clinic would make the final diagnosis.
- 3. As to patients who display TS symptoms, hormonal therapy should be started in conjunction with continued psychotherapy.
- 4. In those cases where the hormonal therapy has been beneficial, the social gender change should be recommended. In the case of the male patient, extensive electrolysis should precede the gender change.
- After several months of living in the chosen gender and having bene-
- After several months of living in the chosen gender and having bene-fitted from hormonal therapy, surgical reassignment should be seriously considered for any patient who demands it. After a minimum of 9 months of psychotherapy, hormonal therapy, and real-life test, surgery should be sheduled for any patient who meets all of the requirements: a) Physically able to withstand surgery b) Of legal age CR with consent of guardian who was counseled by the psychiatrist who rendered psychotherapy to the patient
 - the psychiatrist who rendered psychotherapy to the patient c) AND on the demand by the patient.

Sex-Change Man Changes Back

He was a man who became a woman - and now he's back to being a man!

In one of the most bizarre sex-change stories ever, Ronald Earl Rigsbee had surgery to turn him into a woman - then 10 years later had an operation to make him back into a man.

When he was a woman, Rigsbee says, he was raped and dis-criminated against, got into lesbian relationships and became so despondent that he tried to kill himself 36 times.

And then, he says, God called him to become a man again . . . and work as an evangelist who can understand the problem of either sex!

"As Susan Jeanette Fontaine, I fooled everyone - my female roommates, my boyfriends and even doctors," Rigsbee told The EN-QUIRER in an exclusive interview. "The only person I couldn't fool was myself. But when I was down as low as any human being can be, God reached down and saved me.

"It was at that point I knew He wanted me to be His little Ronnie once again. And I am repaying God by not only becoming the man He created, but also an evangelist to spread His word." Born a boy in 1944, Rigsbee grew up con-fused and dreaming about frilly dresses and

growing up into a beautiful woman.

growing up into a beautiful woman. After a stint in the Navy, Rigsbee tried a number of jobs and finally became a junior administrator at a Philadelphia college. "I set about becoming a respected man in the community," he said. "But I wasn't happy. As hard as I tried to work at being a man, I felt incomplete."

That's when Rigsbee read an article describing sex-change surgery. In 1970, at age 26, he underwent operations that changed him from a man into a woman.

"Waking up after surgery to find I was a woman was one of the happiest moments of my life," he remembered.

Rigsbee went on to have almost 20 more operations — including ex-tensive cosmetic surgery — to become the most perfect woman possible. He changed his name to Susan Jeanette Fontaine.

But life as Susan wasn't the bed of roses Ronnie had thought it would be. The initial shock came when he was

raped. "I know it's something every wom-an fears. But for me it was totally horrifying," he said. "This was my first sexual experience as a woman. I'd gone to a club in the Lower East Eide of New York City to apply for a job as a dancer. The club manager locked the office door, then attacked and raped me.

"It was hard to forget such a terrifying experience. I wanted my knight in shining armor. I wanted to march down the aisle in pure white. I wanted a loving husband and children. I wanted all those things every woman

wants. And this experience had spoiled it. "For more than a year I couldn't have anything to do with men. For a short time I even became a lesbian. This may seem odd because as a man I had never enjoyed making love to women. But as a woman, I was re-volted by what I saw as the sexual exploitation of women by men.

"I remember one job I had as a barmaid.

"Men would try to pick me up. They'd say, 'Hey honey, how about coming up to my place tonight?' And

I wanted to tell them, 'I know that line. I've been a man myself.' But of course I didn't. I kept my identity a secret.''

As Susan, Rigsbee lived with fe-male roommates. "None of them ever knew my secret," he recol-lected. "I was just one of the girls. "None of my boyfriends ever knew

Ronnie was in FIMthe Navy before his first sex change.

I was once a male either. Even doc-tors didn't know my past," said the man who switched and then switched back.

But Rigsbee was not happy as Su-san. "I was depressed," he said. "Even though the world saw me as a normal female, I was not normal. I thought of myself as a woman and I

looked like a woman, but going to bed with a man was still something unnatural. It wasn't right.

Thirty-six times, Susan tried to kill herself, said Rigsbee.

Then in 1980, she began to attend church. "This was the turning point in my life. I began asking myself, 'Who am I? Suzie or Ronnie? Male or fe-male?'

"Finally I came to the realization that I could never serve the Lord completely as Suzie. She had to go so that the man God had created could

live. "I realized then that Suzie had

been a lie. -"If God had intended me to be fe-male, He would have created me that way," he said. So last November, Rigsbee went

back to being a man again — he had his breasts removed and underwent hormone-treatments.

Although doctors could not restore him completely as a man, Rigsbee said, "I will live out the remainder of my days as a eunuch for the Lord — a male who has special insight into the problems of all God's children, male and female."

Rigsbee has become an evangelist in Charlotte, N.C. "Suzie is dead and buried. I am

Karen F. Ulane – a pilot for East-ern Airlines – has filed a \$4 million lawsuit in Chicago charging she was fired because of her sex-change operation. Ulane, 39, who worked 12 years for the airline as Kenneth Ulane, was fired April 24. Ulane, who flew air transport missions during the Vietnam War, is seeking reinstatement to her pilot's job, back pay, \$4 million in com-pensatory damages and an unspecified amount in punitive damages. Fay Clayton, Ulane's attorney, said her cli-

ent, who is divorced, told Eastern officials of her sex-change plans during the winter of 1979. She said the airline never indicated that Ulane would be out of a job after the operation. Clayton said her client had passed medical and psychological tests and received a first-class medical certificate from the Federal Aviation Administration. The suit includes a letter signed by Thomas R. Buttion, Eastern's senior vice president for operations, telling Ulane that pilots indicated they would not fly with her. Ulane's presence, the letter added, "would undermine the effort to reas-

sure passengers as to the safety of air transporation" and said she would not have been hired if Eastern had known she was contemplating a sex change. Clayton said the Airline Pilots Association has filed a grievance on behalf of Ulane, who once was a union representative for the group. Ulane attempted to settle the case out of court, but rejected Eastern's offer of \$2,100 a month, Clayton said. As a pilot, she had earned more than \$50,000 a year.
